

**SHEBOYGAN COUNTY    ORDINANCE NO. 21 (2006/07)**

**Re:    Amending Chapter 47: Supervisor - Outpatient Services Position**

**WHEREAS**, there is a vacancy in the Health and Human Services Department position of Supervisor, Clinical Treatment/Intake Assessment Unit, a Ph.D. Pay Grade 17 position, and

**WHEREAS**, in reviewing the position in the context of refilling the position, it has been determined that the title of the position in Chapter 47 should be changed to "Supervisor - Clinical Treatment/Intake Assessment to make it consistent with the title in Chapter 40, and

**WHEREAS**, in reviewing the position in the context of the current job market and the clinic licensing requirements, it has been determined that the County could potentially need to exercise the option of hiring a Pay Grade 14 Masters level candidate and contract out for the services that require Ph.D. credentials, and

**WHEREAS**, in order to provide the broadest flexibility to the County, it is proposed that an additional line-item be added to Chapter 47 for a Masters level Grade 14 position and that the candidate ultimately hired be designated as either a Grade 14 or a Grade 17 based on educational qualifications, and it is further recognized that this manner of addressing the situation would not require adding a new position to the Chapter 40 Table of Organization;

**NOW, THEREFORE**, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1.     **Amending Chapter 47.** Section 47.06, Pay Grades 17 and 14, of the Sheboygan County Code of Ordinances is hereby amended as follows:
