

SHEBOYGAN COUNTY ORDINANCE NO. 06 (2007/08)

Re: Designating Prohibited Parking Zones on Certain County Roads

** Amended*

WHEREAS, Wis. Stat. § 349.13(1e) authorizes County Boards to regulate the stopping, standing, or parking of vehicles with respect to highways under their jurisdiction, and

WHEREAS, within the reasonable exercise of its police powers, the Sheboygan County Board believes that it is appropriate to prohibit parking on a portion of County Road "I" in the Town of Lima as follows:

From the intersection of County Roads "I" and "V" northeast for a distance of 300 feet for each side of the road,

and

WHEREAS, within the reasonable exercise of its police powers, the Sheboygan County Board believes that it is appropriate to prohibit parking on a portion of County Road "V" in the Town of Lima as follows:

From the intersection of County Roads "V" and "I" east for a distance of 350 feet on each side of the road,

and

WHEREAS, within the reasonable exercise of its police powers, the Sheboygan County Board believes that it is appropriate to prohibit parking on a portion of County Road "P" in the Town of Rhine as follows:

From the entrance of the Sheboygan County Boat Launch and Parking Area south for a distance of 300 feet on each side of the road and north for a distance of 300 feet on each side of the road;

NOW, THEREFORE, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1. **Establishing No Parking Areas on County Roads**. Section 21.08 of the Sheboygan County Code of Ordinances is hereby amended so that new Subsections (l), (m), (n) and * (o) are added as follows:

(l) * *On the west side of County Road "I" at its intersection with County Road "V" northerly for 300 feet.*

(m) * *On the south side of County Road "V" at its intersection with County Road "I" easterly for 350 feet.*

(n) * *On the north side of County road "V" at its intersection with County Road "I" easterly for 170 feet.*

(o) * On the east side of County Road "P" from County Road "JP" to Lakeside Park Road.

Section 2. **Effective Date.** The herein Ordinance shall take effect upon enactment, publication, and posting of "no parking" signs as required by Wis. Stat. § 349.13.
