

SHEBOYGAN COUNTY ORDINANCE NO. 10 (2007/08)

Re: **Amending Planning Department Table of Organization to Create Land Use Planner Position**

WHEREAS, through the enactment of Wis. Stat. § 66.1001 ("Smart Growth"), Sheboygan County through its Planning Department has been mandated to undertake additional planning activities, and

WHEREAS, part of the requirements of Wis. Stat. § 66.1001 requires Sheboygan County to complete its Comprehensive Plan by January 1, 2010, and

WHEREAS, the Planning Department is receiving more frequent requests from the public, other County Departments, and local communities for mapping projects and planning information, and

WHEREAS, a project-specific Land Use Planner added to the Planning Department Table of Organization (T/O) could address the increasing requests for services that the Planning Department is receiving and could be responsible for overseeing the completion of Sheboygan County's Comprehensive Plan under the direction of the Planning Director and the Resources Committee, and

WHEREAS, the Planning Director has recommended that a new position of Land Use Planner at a union grade 10 be determined should be added to the Planning Department's T/O with a sunset clause upon the deadline for the completion of the Comprehensive Plan, and

WHEREAS, the present and proposed T/O can be summarized as follows:
