

SHEBOYGAN COUNTY ORDINANCE NO. 11 (2007/08)

Re: **Increasing Jail Reimbursement from Prisoners**

WHEREAS, through the enactment of Ordinance No. 4 (2001/02), Sheboygan County has taken advantage of legislative changes which enhance the ability of the County to obtain reimbursement for the cost of incarcerating persons confined to County correctional facilities, and

WHEREAS, the reimbursement schedule created as part of Ordinance No. 4 has not been updated since the enactment of Ordinance No. 13 (2002/03), and

WHEREAS, since 2002, the expense for which reimbursements are being sought have been increasing significantly, and an increase in the cost charged to prisoners for such expense is appropriate;

NOW, THEREFORE, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1. **Amending Maintenance Costs for County Jail Prisoners.**
Section 52.03 of the Sheboygan County Code of Ordinances is hereby amended as follows (deletions indicated by strikeouts, additions by redlining):

52.03 COST OF MAINTENANCE. The actual per day cost of maintaining a prisoner is determined to be as follows:

(a) For a person confined to the Sheboygan County Jail and who was given "Huber" privileges pursuant to Wis. Stat. § 308.08 or work-release privileges pursuant to Wis. Stat. § 973.09(4), the sum of ~~Fifteen~~ **Eighteen** Dollars (~~\$15.00~~**18.00**) per day together with a processing fee of Thirty Dollars (\$30.00) for each period of confinement.

(b) For a person in a home detention program pursuant to Wis. Stat. §302.425, the sum of ~~Twenty-five~~ **Thirty** Dollars (~~\$25.00~~**30.00**) per day together with a processing fee of Thirty Dollars (\$30.00) for each period of confinement.

(c) For a person in ordinary confinement, the sum of Twenty Dollars (\$20.00) per day, together with a booking fee of Thirty Dollars (\$30.00).

(d) For medical expenses incurred by Sheboygan County, the actual cost of medical expenses.

(e) For a person confined to the Sheboygan County Jail with "Huber" privileges pursuant to Wis. Stat. §303.08 or work-release privileges pursuant to Wis. Stat. §973.09(4) as a result of a transfer to Sheboygan County from another jurisdiction, a one-time transfer fee of Fifty Dollars (\$50.00) per prisoner transfer, plus the other fees set forth in Subsection (1), above.

Section 2. **Effective Date**. The herein Ordinance shall take effect upon enactment.
