

**SHEBOYGAN COUNTY    ORDINANCE NO. 18 (2009/10)**

Re:   **Adding One Correctional Officer to Sheriff's Department Table of Organization**

**WHEREAS**, the Sheriff's Department is currently operating with 54 Correctional Officers on its Table of Organization to staff Phase I and Phase II of the Detention Center as well as the juvenile and female prisoner sections at the Sheboygan County Jail, and

**WHEREAS**, 24 hours a day there must be at least ten (10) Correctional Officers on duty to staff Sheboygan County's correctional facilities, and

**WHEREAS**, in order to adequately staff the correctional facilities, the Sheriff's Department has had to rely upon significant use of overtime, and

**WHEREAS**, the significant use of overtime has contributed to a significant amount of correctional staff turnover relative to the patrol staff which in turn exacerbates the use of overtime, and

**WHEREAS**, the significant use of overtime has contributed to a significant amount of sick time usage by correctional staff relative to patrol staff which in turn further exacerbates the use of overtime, and

**WHEREAS**, by the enactment of Ordinance No. 7 (2008/09) the County Board added two (2) more Correctional Officers to the Sheriff's Department Table of Organization, and while, as a result, the Sheriff's Department has experienced some relief from the turnover, sick time, and overtime problems, it is not enough, and

**WHEREAS**, the Sheriff's Department believes that adding one (1) more Correctional Officers to the Table of Organization would be necessary to fully address the turnover, sick time, and overtime problems as well as associated morale problems, and

**WHEREAS**, the Sheriff's Department believes that a substantial portion of the expense of an additional Correctional Officer would be paid for by the reduction of overtime, and

**WHEREAS**, the findings of the Virchow Krause Organizational Study indicate that the Corrections Division is understaffed by as many as three (3) Correctional Officers;

**NOW, THEREFORE**, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1.    **Adding One Correctional Officer**. Section 40.02(u) [with regard to Administration] of the Sheboygan County Code of Ordinances is hereby amended as follows:
